




The Phoenix Police Department is releasing the following information pursuant to A.R.S. 13-3825, the Community Notification on Sex Offenders Law. The offender in this publication is living in Phoenix, Arizona. Notification must be made when certain sex offenders are released from the Arizona State Prison, accepted under an interstate compact or released from the county jail back into the community. Offenders are categorized into three levels: Level One (low risk to the community), Level Two (intermediate risk to the community), and Level Three (high risk to the community).

The individual who appears on this notification has been convicted of a sex offense which allows for community notification. He is not wanted by the Phoenix Police Department at this time. This individual is currently under probation supervision. His probation officer is Ramon Grijalva and can be reached at 602-619-2480.

This notification is not intended to increase fear; rather, it is our belief that an informed community is a safer community. The Phoenix Police Department has no legal authority to direct where a sex offender may or may not live. Unless court ordered restrictions exist, this offender is constitutionally free to live wherever he chooses. Citizen abuse of this information to threaten, intimidate, or harass sex offenders will not be tolerated. Sex Offenders have always lived in our communities; but because of Megan's Law, law enforcement is now able to share this information with you.

On June 24, 2020, Drake was convicted of Sexual Conduct with a Minor in the Maricopa County Superior Court. Drake engaged in non-consensual sexual conduct with a minor female, who was known to him.

El 24 de junio de 2020, Drake fue condenado por conducta sexual con una menor en el Tribunal Superior del Condado de Maricopa (Maricopa County Superior Court). Drake tuvo conductas sexuales no consensuadas con una menor a quien conocía.

El Departamento de Policía de Phoenix da a conocer la siguiente información en conformidad con el estatuto A.R.S. 13-3825, la Ley de Notificación a la Comunidad Sobre Delincuentes Sexuales. El delincuente en esta publicación vive en Phoenix, Arizona. Se debe hacer una notificación cuando ciertos delincuentes sexuales son liberados de la Prisión Estatal de Arizona, aceptados bajo un acuerdo interestatal, o liberados a la comunidad por la cárcel del condado. Los delincuentes están categorizados en tres niveles: Nivel 1 (bajo riesgo a la comunidad), Nivel 2 (riesgo intermedio a la comunidad), y Nivel 3 (alto riesgo a la comunidad).
